The Problem

Every year, thousands of military personnel suffer career-ending disabilities in service to our country. These heroes have the right to be processed for Medical Retirement, Medical Separation, and/or Retention through the Department of Defense's (DoD) Disability Evaluation System (DES).

Unfortunately, the Military separates thousands of wounded warriors every year prior to delivering a satisfactory resolution to their disability determination. Mentally and physically broken, suddenly unemployed, and unceremoniously abandoned by the military – these veterans need a lifeline to pull them through an overwhelming and tumultuous DES appeals process and to guide them back on to stable ground.

History. Founded in 2018 by Peter Faerber – an experienced DES attorney, JAG, and LtCol with 28 years in the US Marine Corps – The Warriors' Lawyer is the only certified 501 (c) (3) non-profit organization with an exclusive focus on protecting the rights and entitlements of injured service members and fixing the DoD's broken DES.

Mission. Fight to ensure that wounded, ill, or injured Service Members and Veterans are afforded their full rights to determination and appeal within the DoD's DES – at absolutely NO COST to them!

Vision. Create a culture and system that guarantees our nation's heroes are taken care of – commensurate to their sacrifice.

Programs. We focus on three primary areas of DES-related legal support:


- DES Training & Education Program. We conduct regular educational sessions

 the word regarding the DES.
- DES Legislation & Advocacy Program. We disseminate timely and accurate
 information regarding DES cases and issues with military commands, elected
 officials, federal judges, and other community leaders enabling them to drive
 change in the relevant laws, underlying processes, and specific actions related
 to DES.
- DES Legal Support Program. We provide free legal advice, support, and representation for our clients throughout the DES process to ensure optimal disability determination outcomes via the DES.
